OVERVIEW

The Holy Family Catholic School Principal, President, Faculty, Administration and Communications offices provide regular and detailed updates to the Holy Family Community about the activities of the school through the e-newsletter, weekly newsletter, athletics newsletter, quarterly updates, Annual Report, Sentinel Magazine, Principal's reports & copies of presentations on the school website, announcements via email, website and social media. This information is also shared at regular meetings of the Board of Advisors or committee meetings.

The Board of Advisors utilizes a consistent **Meeting Agenda** and **Meeting Minute** outline with the purpose of documenting high level topics discussed and any consultative action taken by the Advisors. A summary of these minutes can be found below and will be posted on the school website for the 2024-2025 school year.

A <u>**Consent Agenda**</u> is used to streamline meeting procedures by collecting routine, noncontroversial items into a group whereby all are passed with a single motion and vote. The presiding officer announces the items on the consent agenda, asks if any should be removed, then declares the consent agenda adopted unless there's objection. Any Director can have an item removed from the consent agenda for separate consideration.

Consultative voting is exercised by Advisory Board Members as common meeting practice (Advisors do not have governing authority). **Deliberative voting** is exercised in meetings of Directors who have specific authority and powers outlined in the bylaws.
