Fees will be charged in two installments via FACTS billing: \$182.50 due January 31, 2022, and \$182.50 due February 28, 2022. Late fee of \$25 will be assessed if miss either deadline.

TUITION AND FEE PAYMENT OPTIONS

All families are expected to make tuition payments by ACH according to one of the options below. All families are required to setup a FACTS agreement for tuition payments and for incidental billing. Incidental billing could include registration fees, school supplies and various student fees.

A. Full Payment. Under this plan, the entire amount of tuition should be paid through FACTS on or before **July 29, 2022**. A \$100 discount is offered for full payment made prior to June 30, 2022.

B. Monthly payments. Under this plan, parents will select a 10, 11 or 12-month payment plan. The 10-month plan will run from August to May. The 11-month plan will run from July to May. The 12-month plan will run from June through May. The monthly plans permit parents to pick from five various draft dates which include 5th, 10th, 15th, 20th or 25th of each month beginning in June, July or August 2022. All students' tuition must be paid in full by **May 25, 2023**.

C. Early Withdrawal/Tuition Refund. Twenty percent of gross tuition is assessed for early withdrawal after August 1, 2022. Tuition refund will be prorated based upon the number of school days at time of withdrawal and a 20% retainment of gross tuition for early withdrawal.

* **FACTS Tuition Management:** The annual FACTS Enrollment Fee is \$50 for the monthly payment option and \$20 for a pay in full option. Returning families will be charged for half the fee (\$182.50) on **January 31, 2022**, and the other half of the fee on **February 28, 2022** with the payment option on file.

Tuition Assistance: Applications for tuition assistance opens January 1, 2022. Applications must be submitted online through FACTS Grant & Aid by February 25, 2022, to meet the first round of awards.

The following information is required in order for FACTS Grant & Aid Assessment to process your application:

- Submit a completed online application. FACTS Grant & Aid Assessment will process one application per household. The FACTS Grant & Aid Assessment application can be accessed through the school website: <https://www.holyfamilycs.org/admission/financial.cfm>
- A non-refundable fee of \$40.00 is required prior to sending your supporting documents.
- Copies of your 2020 or 2021 IRS Federal Form 1040, 1040A or 1040-EZ U.S. Individual Income Tax Return (2 pages), including all supporting tax Schedules C or C-EZ, Schedule E, Schedule F, Depreciation Form 4562, S Corporation Form 1120S (4 pages) & Schedule K-1 and Form 8825, Partnership Form 1065 (5 pages) & Schedule K-1 and Form 8825, Estates and Trusts Form 1041 & Schedule K-1. If applicant and co-applicant file separately, both tax returns for the same tax year are required.
- Copies of all 2021 W-2 Wage and Tax Statements for both you and your spouse.
- Copies of all supporting documentation for household Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and Temporary Assistance for Needy Families (TANF).

Please allow 3 to 4 weeks for your application to be processed. Be sure to check your primary e-mail address you listed on your electronic application for notices sent by FACTS Grant & Aid Assessment indicating missing information or tax documents. Application deadlines are set by Holy Family Catholic School.
